Terms and Conditions

Authorization Validity:

This authorization is valid only if the applicant is at least 19 years of age.

This authorization expires one year from the date of approval unless otherwise specified by SLGA.

The applicant may import wine and craft spirits under this authorization only for personal consumption at a private residence or other private place where it is lawful to store and consume alcohol.

Beverage alcohol may be ordered and imported under this authorization only from a winery or craft distillery located in British Columbia.

Delivery Conditions:

The applicant may place as many orders as desired during the term of this authorization, but shall not import more than nine litres of wine and three litres of craft spirits per order or shipment.

Beverage alcohol imported under this authorization must be received by the applicant at a private residence or other private place in Saskatchewan where it is lawful to store and consume alcohol. Beverage alcohol imported under this authorization cannot be delivered to a hospital, institution, or other facility where the nature of the facility is to treat alcohol/substance abuse addictions.

The applicant will be required to show proof of age to the delivery company, regardless of apparent age.

The delivery company is prohibited from delivering beverage alcohol if the applicant is or appears to be intoxicated.

If the applicant is unable to fulfill any of the above-noted conditions at the time of attempted delivery, arrangements may be made to complete delivery at another time.

Importation Levy:

Beverage alcohol imported under this authorization is subject to an importation levy in the amount of \$7 per litre for wine and \$12 per litre for craft spirits.

Within 30 days of receiving a delivery of beverage alcohol imported under this authorization, the applicant must submit to SLGA a report stating the quantity of wine and/or craft spirits imported, along with payment of the applicable importation levy.
